

Jason Bell, a 5-year-old former Independence Elementary kindergartner and Villages of Woodland Springs resident, was diagnosed at the end of September with Primary Pulmonary Hypertension. ("Pulmonary Hypertension (PH) is high blood pressure in the arteries of the lungs that can lead to heart failure." www.phassociation. org) This is a very serious disease, which, unfortunately, has no cure. Jason's parents found a specialist in Florida and Jason was recently accepted into a medical treatment program that has to be done internationally, his blood work is being sent to Israel, and the procedure will be done in the Dominican Republic. The procedure involves using Jason's own stem cells in his blood to relieve the pressure on his heart, thereby prolonging his life.

The medical treatment is not FDA approved, so insurance won't cover the costs. Jason's parents have to pay the medical costs out-of-pocket and up front before the procedure is done. I was told the surgery portion alone was \$57,000 (not including transportation, lodging, or after care when they return home), and it may have to be done twice to be effective.

A group of the Bell family friends are working together to spread the word about Jason's condition, and how we, as a community, can help the Bell family. We have already set up donation jars at school and several local businesses.

We have gone online to spread the word about Jason. His story is available at CaringBridge, a website that his parents used most frequently when he was at the hospital to keep family informed of his condition. Covenants Corner: Exterior Accessories, Surfaces & Roofing

5.3.2 Exterior Accessories, Surfaces & Roofing. Installation of all exterior items and surfaces, including address numbers, decorative hardware, external ornamentation, lights fixtures, and exterior paint and stain, is subject to the ACC's prior approval, including approval of design, color, materials, and location. Roofing shall be of a substance acceptable to the City, shall be covered by a manufacturer's warranty of at least 20 (twenty) years. The approved colors for roofing shingles are Weathered Wood and Weathered Slate or as determined by Board or ACC.

If an existing roof (installed prior to September 1, 2010) has a different color which was not approved by the ACC prior to installation it is a nonconforming color. The next roof installed on this home must comply with one of the two approved colors unless the ACC grants a variance.



Shutting Off All Pool Cards.... Why, You Ask?

VOWS will be performing a pool access card system software upgrade prior to the 2012 Pool Season. In effort to clean up the current access card system database and update the contact information for all Homeowners, we will be shutting off all currently issued pool cards. By shutting off the pool access cards, we will be able to eliminate the usage of previously unreported missing, lost, or stolen cards. Additionally, this measure will assist greatly in ensuring that only those Residents that are presently current with the Association are able to access the community amenities and facilities.

If you currently are a Homeowner of a tenant (renter) please also inform us with the following information. Copy of the lease agreement, can be brought in as proof of residency to turn the pool card back on. As stated in the DCCR's: The Governing Documents shall apply to Owners as well as occupants of Lots and their respective tenants, guests, and invitees. Any lease of a Lot shall provide that the lessee and all occupants of the leased Lot shall be bound by the terms of the Governing Documents. 5.3.14 Leasing of Homes. All owners must register all lessees/tenants with the Association within thirty (30) days of each lease. The registration must include the following information:

- a. Tenant(s) full name
- b. Tenant(s) contact information
- c. Full names of all additional occupants not listed in the lease agreement
- d. Commencement date of lease
- e. Expiration date of lease
- f. The name, address, and phone number of owner's managing agent, if any

Landscape Committee Report

Ho...Ho...Ho, Hope you have great holidays! I think we all can find many things to be thankful for if we stop and ponder our blessings for a moment. One very special thing is our community. A clean, safe and attractive place we can all call home together. And now that the Holiday decorations are hung and our Landscape contractor The Brickman Group is going about their business of tidying up the neighborhood this is the perfect time to share a few winter highlights from the landscape committee:

- Waterworld? The VOWS pond near Lauren Way now has a decorative fountain installed, and functioning - drive along Keller Hicks between Lauren Way and Blue Jack to enjoy the view.
- Long Hot Summer, the Texas summer took its' toll on VOWS plants. The new and even some the established plant materials suffered. The inventory, assessment and replacement of these plants is already underway and the new ones will be of a hardier, more drought tolerant selection to tolerate the anticipated drier summers.

- Details details....It's the little things that count and residents may be noticing some of them lately. Work on the raised planter box showcasing our seasonal color at the western Timberland entrance is almost complete, and night lighting will also be added. Detail work on the southern Woodland Springs' entrance will be undertaken to spruce up its appearance with some turf leveling, plant replacement and edging adjustments. The 6 new corner beds on North Caylor and along Park Vista are now complete. Also all corner beds in the neighborhood are being "amended" which means additional soil materials are being added to boost their nutrient content and to level beds that have been eroded. This helps conserve moisture and all of these efforts should improve the survival rates of the plants that have to live there. The winter flowers for the corner beds will also be held out to allow for this process to continue and at the same time will reduce our associated color change-out expense. This allows VOWS to pocket the savings and use it to replace lost plant materials and higher water costs accumulated over the summer. Color will be reinstalled in these



beds in late winter/early spring. More on that next time.

- No it's not a dog house..... but my pooch said, "It roofs rike a nice run ron't it?" VOWS has several electric pumps that circulate water for our pond fountains. In the past some of these pumps have suffered expensive freeze damage in the winter. The current artificial plastic-boulder covers are at best inadequate and not very convincing so it was suggested VOWS could save money and create an attractive façade by installing small site-built covers. Check out the first prototype by the iron fencing, just north of the first pond along the eastern side of Woodland

Springs. Let us know what you think.

- Lastly, we have applied for another round of free shade trees from the City of Fort Worth, Community Tree Grant Program, requesting 78 new trees to be installed around VOWS. The majority of these will be on the west side of VOWS. Look for them along Timberland and others streets within our community. Installation will be between the curb and the sidewalk sometime in February depending on the weather. Brickman workers will appreciate your reduced driving speed and caution while they complete their work.

Woodland Springs Homeowners' Association

The purpose of a homeowners' association (HOA) is to maintain, enhance and protect the common areas and interests of the subdivision or neighborhood. In order for an individual homeowner to utilize neighborhood amenities (pond, pools, parks, tennis courts, etc.) each member of a homeowners' association pays periodic assessments. The assessments are used to pay for the community expenses such as entrance monuments, landscaping, amenities like clubhouses, tennis courts, or walking trails, insurance for commonly-owned structures and areas, an on-site management company or any other item delineated in the governing documents or agreed to by the homeowners' association.

Currently, the homeowners' association for The Villages of Woodland Springs is comprised of the Board of Directors and Centurion American (the developer). Until full development of the Villages of Woodland Springs is completed, the primary governing body will be the Board of Directors and Centurion American. The intermediate group between the residents and the homeowners' association is the Advisory Committee, which is comprised of elected residents. Sub-Committees report to the Advisory Committee.

Advisory Committee meetings are normally held the 4th Tuesday of each month at 6:30 pm at the Amenity Center on Timberland. The January 2012 meeting of the Advisory Committee will be on January 27. However, in place of the February 2012 meeting, the 2012 HOA Annual Meeting will be held on Thursday, February 16, 6:30 pm at the Amenity Center.
